In consideration of being allowed to participate in the Sunday morning coastal run organised by Stride Run Club ("Stride"), I, the undersigned participant, acknowledge and agree to the following:

- 1. Assumption of Risk: I understand that participating in the run along the coast involves inherent risks, including but not limited to uneven terrain, weather conditions, slips, falls, collisions, traffic hazards, and health-related issues such as dehydration or overexertion. I voluntarily assume full responsibility for any risks, injuries, or damages that I may sustain as a result of my participation.
- 2. Release of Liability: I, on behalf of myself, my heirs, assigns, and personal representatives, hereby release, discharge, and hold harmless Stride, its organisers, leaders, sponsors, and affiliates from any and all claims, liabilities, demands, actions, or causes of action arising out of or related to any injury, disability, death, or loss or damage to person or property incurred while participating in the coastal run.
- 3. Medical Treatment: I certify that I am physically fit and sufficiently prepared to participate in this run. In the event of an emergency, I consent to receive medical treatment deemed necessary by medical personnel. I understand that I am solely responsible for any medical expenses incurred as a result of my participation.

- 4. Code of Conduct: I agree to abide by all Stride rules, and guidelines. I will conduct myself in a respectful and manner and follow instructions given by Stride organisers and leaders. I will also adhere to all traffic and safety regulations while running.
- 5. I understand that I will not receive compensation for the use of these images.
